The dietary safety and health development of our students have always been our top priority, and we will not overlook any related feedback.

To thoroughly understand the situation and take appropriate follow-up actions, PTA has initiated internal procedures, including following up individual issues with the school and formal communication with the supplier. Meanwhile, to gather comprehensive and objective feedback, we sincerely invite parents to provide their valuable input. If you have any specific comments or suggestions regarding the lunch quality (e.g., ingredient freshness, taste, nutritional balance, hygiene, etc.), please kindly fill out the form below and submit it to the school on or before **November 3th 2025**. Specific examples provided by you (such as dates, menu items, and descriptions of issues) will greatly assist us in addressing the matter more effectively.

We firmly believe that student well-being is built upon close collaboration between home and school. **PTA has always been serious about monitoring the lunch suppliers' services, including participating in tender meetings and organizing surprise lunch tasting activities. PTA is committed to handling this matter earnestly and will work closely with the school to resolve any concerns. We encourage constructive discussions among parents and advise refraining from offensive remarks.** We will continue to monitor improvements and remain dedicated to providing safe and high-quality lunch services for our students.
